Sub: Data Entry and Qurrah for Haj-2015

As you are aware, the last date of receiving of Haj Application Forms (HAF) is 2^{nd} March, 2015. It is to be ensured that no HAF with pay-in-slip or passport issued after 02.03.2015 is entered in the IHPMS data base.

- 2. In continuation to this office's earlier letter No.HC-15/29/2015/4417 dated 27th January, 2015, the dates of Data Entry, verification, editing & certification are rescheduled as per enclosed **Annexure I**. Every State/UT Haj Committee should strictly adhere to the dates of Data Entry, verification, editing, certification & qurrah for 2015 as per the schedule. The entire task be completed within stipulated time frame.
- 3. State/UT Haj Committee shall have to send a certificate as per the proforma enclosed of **Annexure II**, two days prior to qurrah in their respective state.
- 4. The infrastructure required at the venue of Qurrah is as under:-
 - (i) One (1)MPBS internet connectivity with back up line,
 - (ii) Two Computer systems,
 - (iii) One Laser Printer,
 - (iv) One LCD Projector with Screen,
 - (v) One UPS.

5. It may be noted that a demo shall be arranged by this office a day prior to qurrah for the users who shall conduct the qurrah. Final qurrah shall be conducted on supervisor login, allowed on the day of qurrah.
