Subject: Advance receipt of International passports in respect of waitlisted pilgrims.

The upliftment of waitlisted pilgrims against vacancies arising due to cancellations is being intimated vide Circulars from time to time. All such waitlisted pilgrims are asked to deposit their entire Haj amount along with pay-in-slips and original machine readable valid passports, with sufficient blank pages for Visa endorsement, through State/ UT Haj Committees by specified dates.

- 2. As it is expected that there will be more cancellations and time remaining will be short, it is advised to approach the wait list pilgrims at specified serial numbers (column No. 4 of **Annexure-A**) and inform them to submit original machine readable valid passports along with recent passport size photograph and the Undertaking (**Annexure-B**), immediately in the office of their State Haj Committees.
- 3. These documents may be kept ready in your office and may be submitted to this office, if, as and when, these pilgrims are given provisional selection status. They may be asked to deposit the requisite amount only thereafter and submit pay-in-slips to Haj Committee of India.
- 4. Since the waiting list is confirmed strictly in serial order only, the State/ UT Haj Committee will have to submit skipping list with proper justification as per proforma prescribed (Annexure-C).
