Sub: Release of Seats under Government Discretionary Quota for Haj-2022

- 2. The aforesaid provisionally selected pilgrims are required to deposit both the instalments of Haj Amount (i.e. Rs.81,000/- towards Advance Haj Amount + Rs.1,20,000/- towards First Balance Haj Amount = **Rs.2,01,000/- per pilgrim**)
- 3. Payments can be made either,
 - a. Online at https://hajcommittee.gov.in; or
 - b. In Haj Committee of India account maintained with SBI or account maintained with UBI through any branch of SBI / UBI having core Banking System by using unique **Bank Reference Number** in the Specified Pay-in-slip on website.
 - c. By cheque of any branch of SBI/UBI in the respective Bank.
- 4. These provisionally selected pilgrims may be advised that after depositing the amount, original valid International Machine-readable Passport alongwith one recent colour passport-size photograph having white-background, Pay-in-slip of the deposited amount, Medical Screening and Fitness Certificate (as per format available on website i.e. https://hajcommittee.gov.in should be submitted to their concerned State Haj Committee.

Further, the State Haj Committees are advised to verify the documents received from the concerned pilgrims and after uploading all documents along with Pay-in-Slip/Medical Screening and Fitness Certificate/ Vaccination Certificate of both doses of Covid-19 etc. shall forward the same to Haj Committee of India, immediately.
